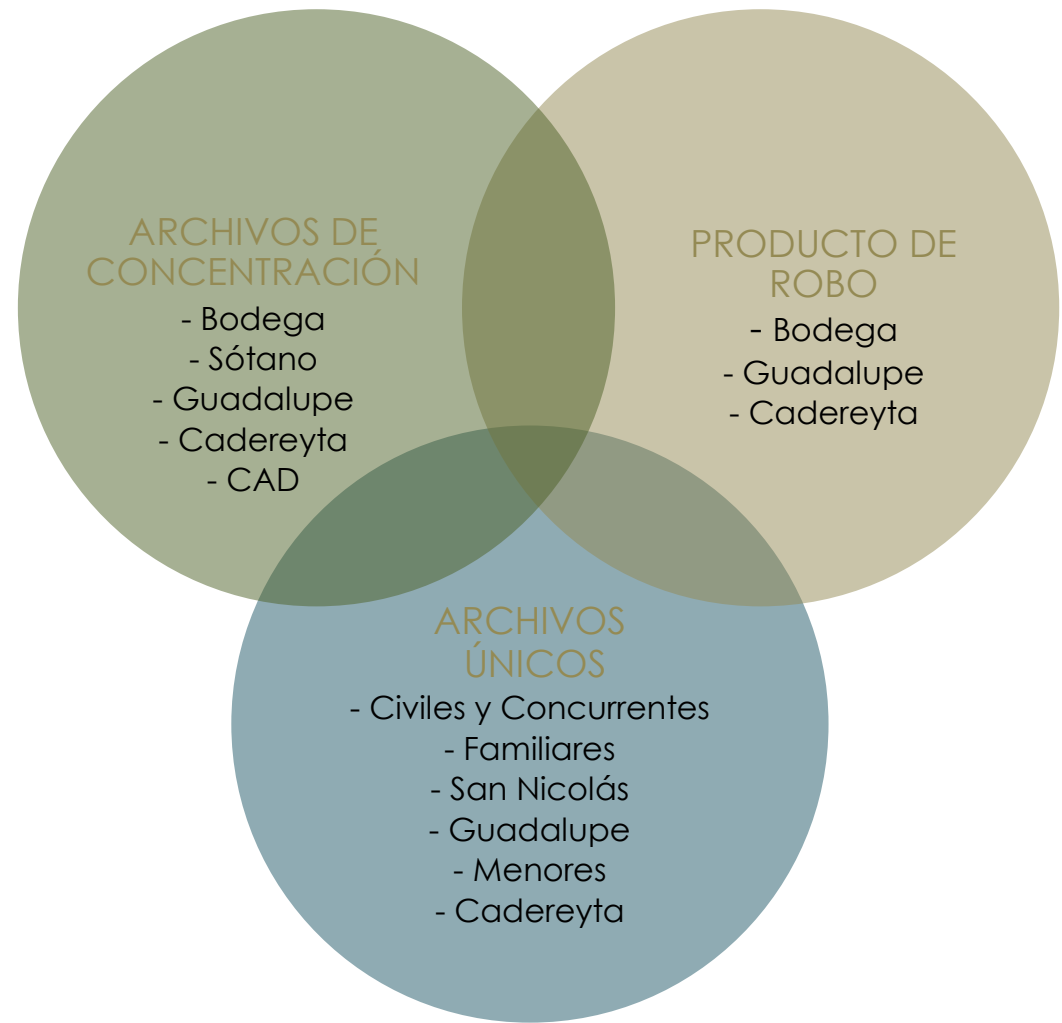


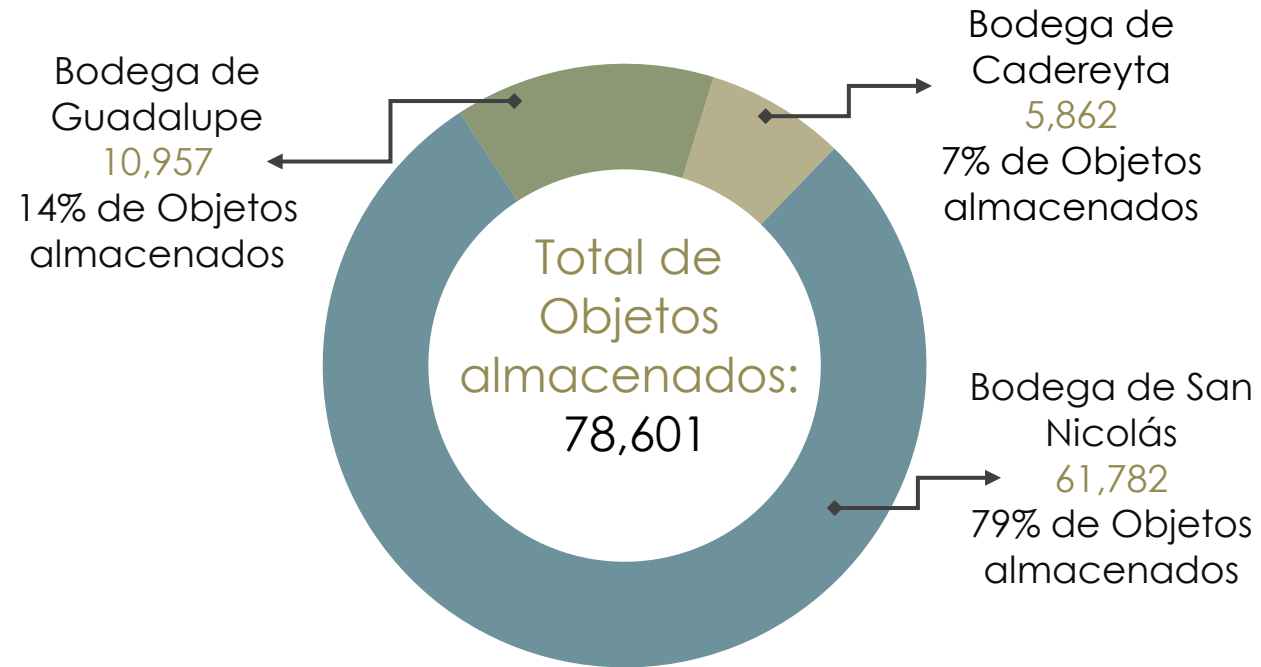

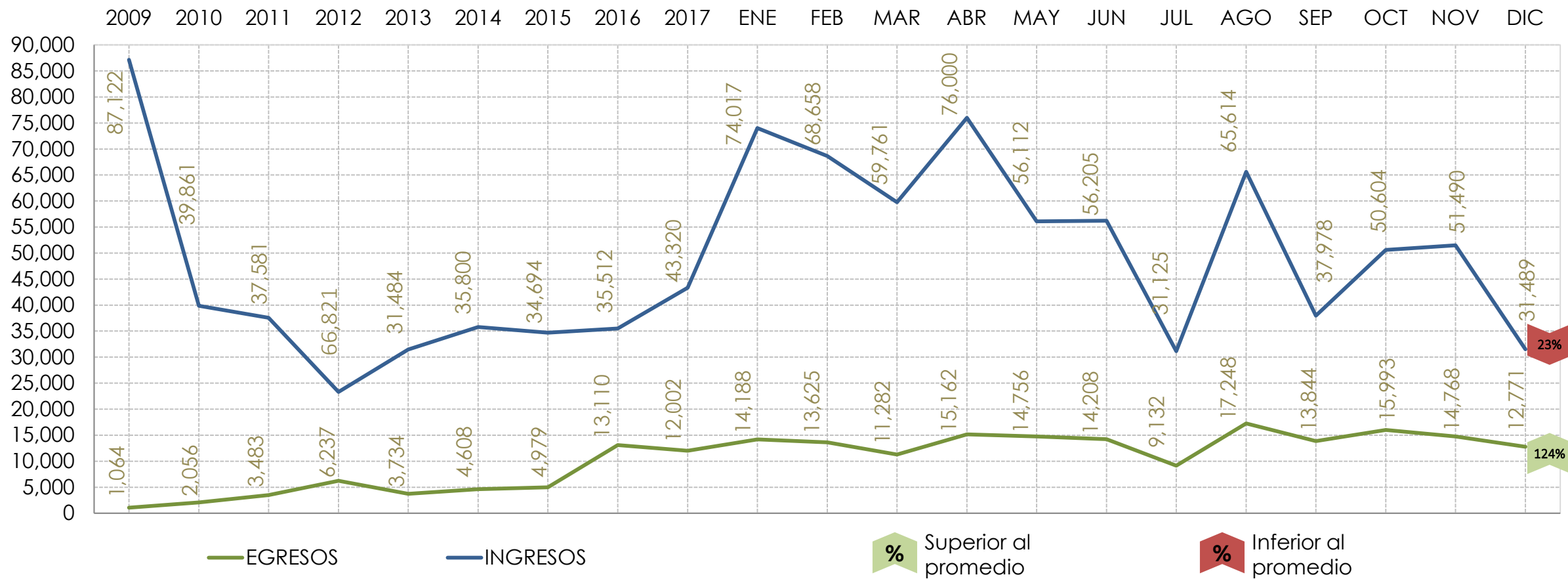


FLUJO DE OBJETOS DE PRODUCTO DE ROBO RECEPCIONES VS. DEVOLUCIONES

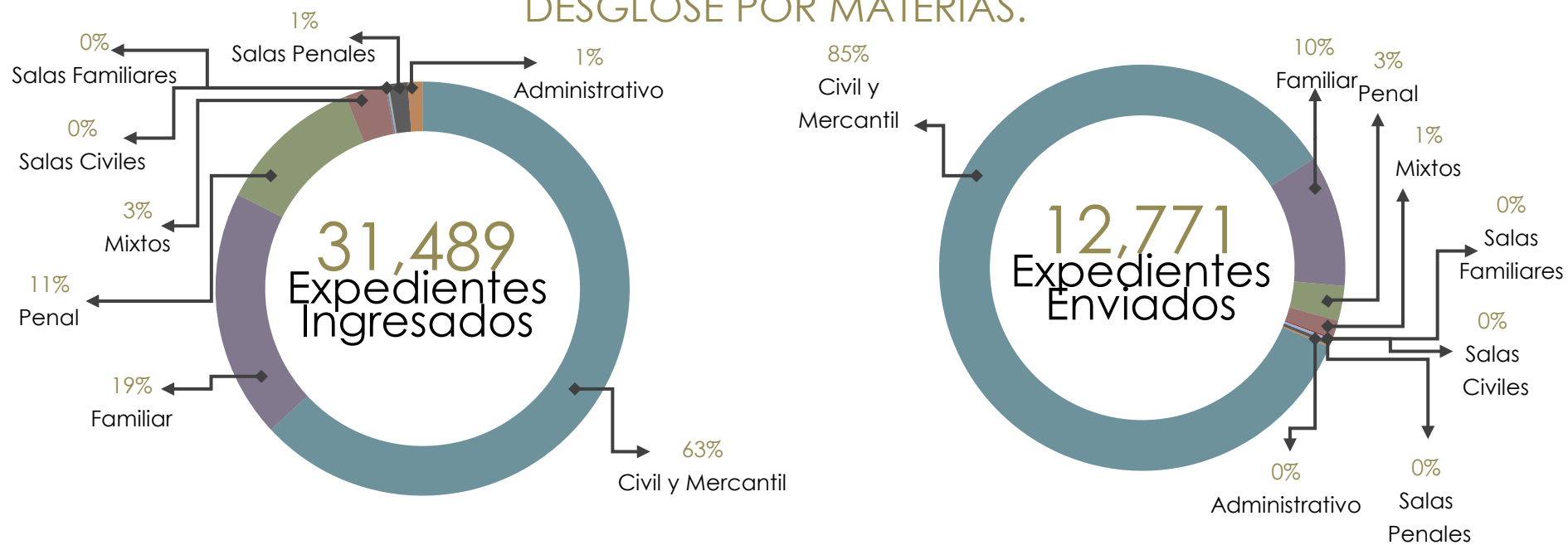

INGRESOS vs. EGRESOS PROMEDIO ANUAL vs. 2018



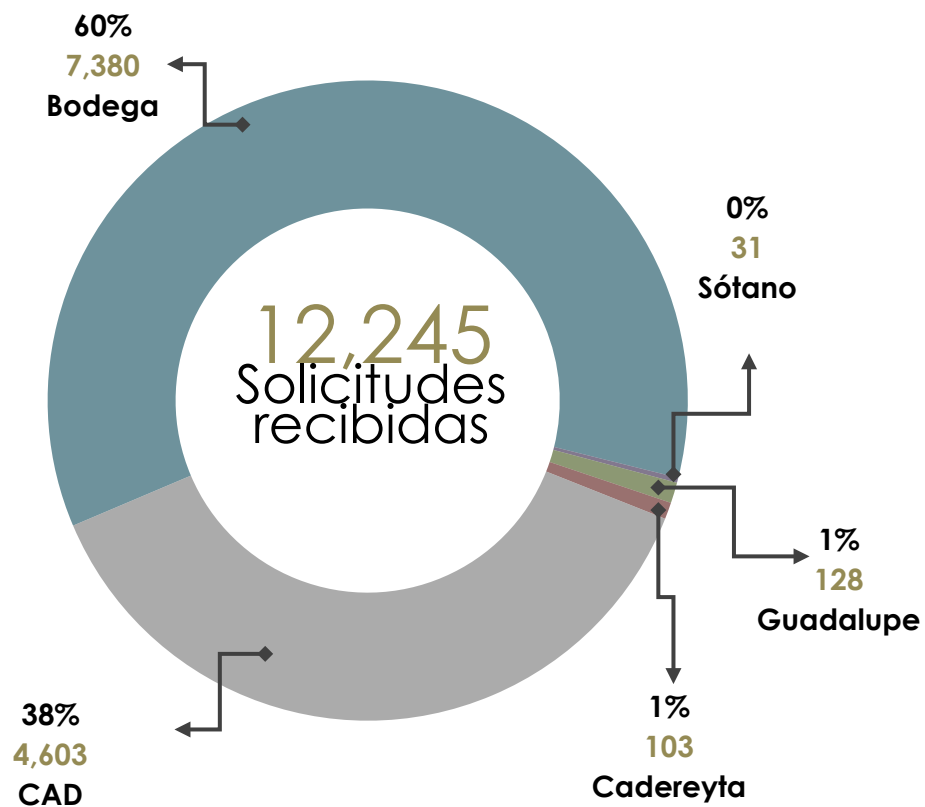
INGRESOS VS. EGRESOS DESGLOSE POR MATERIAS.
